## **Stockport Bramhall Hockey Club Disciplinary Code**

Stockport Bramhall Hockey Club has established a good disciplinary record over a long period of time and is rightly proud of that fact. Despite ever-increasing pressures in hockey the Club is committed to maintaining that record. The disciplinary code provides formal action to be taken for a failure to meet the standards expected in respect to the Stockport Bramhall Hockey Club Code of Conduct. This applies both during matches and at all other times when representing the Club, or being seen to represent the Club.

Captains are responsible for the pre- and post-match behaviour of all associated with their team as well as conduct during matches.

If a card or cards are awarded, Captains are required to report this, and the details of the offence committed, to the Head Coach of the Appropriate Section who will forward the information to the Club Chairperson. Captains are also responsible for ensuring that **any** behaviour which is contrary to the club's code of conduct and may bring the club into disrepute is similarly reported

The Club Chairperson will review the information with the relevant Head Coach and Captain (the Disciplinary Committee).

The Disciplinary Committee will

The procedures of the Disciplinary Committee are:

- 1. The member concerned will be advised of the matters or allegations in writing prior to the meeting.
- 2. If a member is asked to appear they may bring along another member to speak on their behalf or as an observer or to put any facts before the Disciplinary Committee.
- 3. Both the member and the disciplinary committee may call witnesses as appropriate to attend the disciplinary hearing; any witnesses called may be cross examined by either party.
- 4. The hearing will be adjourned to enable a decision to be reached; this will include consideration of the players' previous disciplinary record. On the same date, wherever possible, the member will be informed verbally of the decision and reasons given on how the decision has been reached. If any disciplinary action is to be taken, the player will be informed in writing within 5 days of the hearing. This will include details of the members' right to appeal which will be heard by the Club Chairperson and two further members of the executive committee.
- 5. Minutes of meetings held will be recorded and these will be available for inspection by the member, on written request, where these relate to decisions concerning the member.
- 6. The decisions of the Disciplinary Committee will be final, subject to the right of appeal laid out in the England Hockey Disciplinary Code.

The Disciplinary Committee can impose any penalty that it considers appropriate up to and including a recommendation to the Executive Committee that the member be expelled from the Club.

Such penalties may include: Verbal warning (formal or informal); Written warning; Suspension from playing;

Suspension of membership of the Club for a period to be defined;

Recommendation to the Management Committee of expulsion from the Club;

No further action.

All penalties may have conditions attached at the discretion of the Disciplinary Committee.

Sanctions/penalties imposed by the Club will be at least as severe as those standardly applying in the relevant league in which the infringement took place.
